



## Master of Science in Business Specialization in Accounting

Lehman College Master of Science in Business (MSB) with a specialization in Accounting. Prepares students for careers as highly skilled accounting professionals in various sectors, including public accounting firms, corporations, government agencies, and non-profit organizations. The program is designed for students with a BBA, BA or BS in Accounting who want to pursue a career in accounting but don't wish to become CPAs, which would require them to pursue the MS in Accounting degree.

### Admissions Requirements

- Official transcripts from all post-secondary institutions attended
- Bachelor's degree or foreign equivalent from an accredited school
- Minimum gpa of 3.0 or minimum gpa of 2.8 with two years of supervisory/managerial experience in Accounting
- Must have completed the following courses or their equivalent: ACC 171, ACC 272, ACC 334, ACC 335, and ACC 348
- Two letters of recommendation
- Personal statement (question will be provided in the graduate application)
- Current professional resume
- GMAT score is OPTIONAL
- If educated in a country other than the U.S. review

**Note:** the online-only MSB program option is not available to students studying on a F1 visa as they may take only one online course in a semester to maintain full-time student status.
