Registered Dietitian/Nutritionists (RDN) are food and nutrition experts who provide evidence-based knowledge and practices to help improve the health and well-being of individuals and populations. Registered Dietitians/Nutritionists are food and nutrition experts who work in a wide variety of employment settings, including health care, business and industry, public health, education, research, and private practice. Dietetics is a growing profession as healthcare moves from treatment to prevention.

The Department of Health Promotion and Nutrition Sciences (HPNS), of Lehman College, City University of New York offers a Didactic Program in Dietetics (DPD) through the undergraduate degree in Nutrition and Dietetics. The DPD is based on the standards of Education of the Accreditation Council for Education in Nutrition and Dietetics ([ACEND](#)), of the Academy of Nutrition and Dietetics (AND), [eatrightPRO.org - Academy of Nutrition and Dietetics](#), and the goals of the HPNS Department.

### ***Program Mission***

The mission of the Didactic Program in Dietetics at Herbert Lehman College is to prepare graduates for entry into supervised practice programs that lead to eligibility for the CDR credentialing exam to become Registered Dietitian Nutritionist. The DPD prepares graduates for further education and/or careers in nutrition and dietetics practice in which they are critically minded professionals who value life-long learning and evidence-based interprofessional practice, while working to enhance health and well-being of individuals and communities in various societies, in particular an urban environment like the Bronx and New York City (NYC).

### ***Program Goals and Objectives***

**Goal # 1** – Program graduates will have received the knowledge and skills for successful participation in graduate programs, accredited supervised practice and careers in nutrition, dietetics, food and (or) health.

#### **Objectives**

- a) At least 80 % of students complete the program requirements within 2 years (150% of the program length).
- b) At least 33 % of the program graduates will apply for admission to a supervised practice program within 12 months of graduation.
- c) Of the program graduates who apply to a supervised practice program, at least 33 % are admitted within 12 months of graduation.
- d) The one-year pass rate (for graduates who pass the registration exam within one year of the first attempt) on the CDR credentialing exam for registered dietitians is at least 80 %.

**Goal # 2** – Program graduates will have received the education and guidance to become confident and valued professionals who are prepared for careers in nutrition, dietetics, food and or health to address the changing health needs of individuals, families and community in various societies.

#### **Objectives**

- a) At least 80 % of graduate program directors who responded to our surveys will state that, in general, our graduate was satisfactory prepared for their program within 12 months of graduation.
- b) At least 80 % of supervised practice program directors who responded to our surveys will state that, in general, our graduate was satisfactory prepared for their program within 12 months of graduation.
- c) At least 80 % of respondents on the DPD Alumni survey will rate the quality of Lehman DPD Program as satisfactory or better, in preparing them for their job in nutrition, dietetics, food and or health.

- d) At least 80 % of respondents on the DPD Alumni survey will rate the quality of the DPD as satisfactory or better in preparing them for working in an interprofessional and globally increasing environment.

### ***The Process to Become an Registered Dietitian/Nutritionist (RDN):***

RDNs are credentialed by the Commission on Dietetic Registration (CDR) of the Academy of Nutrition and Dietetics (AND). Requirements for being a RDN include the following:

- Complete a bachelor's degree at a U.S. regionally accredited university or college and course work accredited or approved by Accreditation Council for Education of Nutrition and Dietetics (ACEND) of the Academy of Nutrition and Dietetics.
- Complete an ACEND-accredited supervised practice program at a health-care facility, community agency, or foodservice corporation or combined with undergraduate or graduate studies. Typically, a supervised practice program will run 6 to 12 months in length.
- Masters Degree Requirement: As of January 2024, a master's degree is required to become an RDN. The master's degree can be obtained before, after, or concurrent with the required supervised practice.
- The dietetics major provides you with a bachelor's degree and accredited coursework to become a RDN, which is the first step mentioned above.
- Students in dietetics may apply to supervised practice in their senior year or after graduation and then complete the national examination. The dietetics program provides students with guidance for application to supervised practice but cannot guarantee acceptance or admission to these programs.
- Pass a national examination administered by the Commission on Dietetic Registration (CDR). ### ***After passing the RDN credentialing exam:***

- Obtain state licensure as required by employer and/or state regulations. See below for more information about licensure.
- Obtain 75 hours of continuing professional education (CPE) every 5 years to maintain registration status as a Registered Dietitian Nutritionist. Continuing professional education is essential for lifelong development to maintain and improve knowledge and skills for competent dietetics practice.

### ***State Licensure: New York State Certification as a Dietitian or Nutritionist (CDN)***

The General Requirements to become a Certified Dietitian Nutritionist (CDN) are available at <https://www.op.nysed.gov/professions/dietetics-nutrition/license-requirements> Any use of the titles "Certified Dietitian," "Certified Nutritionist" or "Certified Dietitian-Nutritionist" within New York State requires certification. To be certified as a dietitian-nutritionist in New York State you must: be at least 18 years of age; and meet education, examination and experience requirements. To meet the education and experience requirements for certification in dietetics-nutrition you must have completed a program in dietetics-nutrition leading to the baccalaureate degree or a higher academic credential that is, at the time you completed the program, registered by the New York State Education Department as qualifying for certification in dietetics-nutrition or accredited by the Accreditation Council for Education in Nutrition and

Dietetics (ACEND).

You must submit an application for certification and the other forms indicated, along with the appropriate fee (\$294), to the NYS Education Department Office of the Professions PO Box 22063 Albany, NY 12201. It is your responsibility to follow up with anyone you have asked to send material. The specific requirements for certification are contained in Title 8, [Title VIII \(nysed.gov\)](https://www.nysed.gov/title-viii), Article 157 Section 8004 of New York's Education Law, [NYS Dietetics And Nutrition:Laws, Rules & Regulations:Article 157 \(nysed.gov\)](https://www.nysed.gov/nys-dietetics-and-nutrition-laws-rules-regulations-article-157) and Section 52.25 and Subpart 79-6 of the Commissioner's Regulations, [Regulations of the Commissioner of Education \(nysed.gov\)](https://www.nysed.gov/regulations-of-the-commissioner-of-education) and [NYS Dietetics And Nutrition:Laws, Rules & Regulations:Subpart 79-6 \(nysed.gov\)](https://www.nysed.gov/nys-dietetics-and-nutrition-laws-rules-regulations-subpart-79-6).

Lehman College Nutrition and Dietetics major is an ACEND-accredited Didactic Program in Dietetics (DPD). It fulfills the Academic Requirements for the Certified Dietitian Nutritionist (CDN) certification. In addition to the DPD coursework, the certification requires supervised practice experience and an examination. ***Requirements to become a Nutrition and Dietetic Technician, Registered (NDTR):***

Nutrition and Dietetic Technician Registered (NDTRs) are credentialed by the Commission on Dietetic Registration (CDR) of the Academy of Nutrition and Dietetics (AND). NDTRs provide assistance to RDNs and work under the supervision of an RDN. Requirements to become a NDTR include the following:

- 1) Complete a bachelor's degree at a U.S. regionally accredited university or college and course work accredited or approved by Accreditation Council for Education of Nutrition and Dietetics (ACEND) of the Academy of Nutrition and Dietetics.
- 2) Completion of the required Core Knowledge Assessments (KRDNs), as well as PSY or SOC 166 (or equivalent).
- 3) Obtain a signed DPD Verification Statement from the DPD Program Director.
- 4) Pass the CDR-administered Dietetic Technician Registration (DTR) examination. Please see [Commission on Dietetic Registration](https://www.nysed.gov/commission-on-dietetic-registration)

**Program-Specific Fees:** For each of two Foods Laboratory classes (DFN120 and DFN220 or DFN520 and DFN621) the fee for equipment, disposables, and food is \$45. The total laboratory fee cost for the DPD is \$90.

**Housing:** As Lehman does not provide housing, students attending Lehman need to find their own housing in the New York City metropolitan area. Housing costs are variable depending upon location and other factors.

**Books:** Textbooks are expensive and are estimated to cost between \$500-\$1000. However, many of the courses do not require a textbook and are listed as Zero Textbook Cost.

**Uniforms:** Laboratory uniforms (lab coats and hats) are estimated to cost approximately \$100.

The Accreditation Council for Education in Nutrition and Dietetics (ACEND), formerly known as the Commission on Accreditation for Dietetics Education (CADE) is the Academy of Nutrition and Dietetics' accrediting agency for education programs preparing students for careers as registered dietitian nutritionists (RDN) or dietetic technicians, registered (DTR). ACEND serves and protects students and the public by assuring the quality and continued improvement of nutrition and dietetics education programs. ACEND is recognized by the United States Department of Education as a Title IV gatekeeper. Please see [United States Department of Education](http://www.ed.gov). This recognition affirms that ACEND meets national standards and is a reliable authority on the quality of nutrition and dietetics education programs. ACEND is also a member of the Association of Specialized and Professional Accreditors (ASPA) and abides by its code of good practice.

### ***Didactic Program in Dietetics (DPD) Admission Requirements***

An applicant to Lehman's DPD must first be accepted into Lehman College as a freshman or transfer student or non-degree student.

In order to be admitted to the ACEND-approved DPD within the Nutrition and Dietetics major, an application must be submitted to the DPD Director after completing the following requirements:

- All students must be accepted into Lehman College Culinary and Community Nutrition major and complete at least one semester before transferring to Nutrition and Dietetics to fulfill the DPD requirements.

- Complete DFN 248 (with minimum of B- grade)
- Have (maintain) a cumulative GPA of 3.3 or above
- Grades in science courses are considered. No grade below C- will be accepted

### **Admission from another college:**

All students must apply and be accepted into Lehman College. Credits will be evaluated by the transfer office. Lehman has transfer agreements with many colleges. Once accepted into Lehman College, your transfer credits will be evaluated for Nutrition and Dietetics major. The Didactic Program in Dietetics, Director will evaluate related courses for ACEND Core Knowledge Registered Dietitian/Nutritionist (KRDN) assignment equivalencies with provision of the course syllabi, course description, and provision of assignments completed.



### **Admission from a school outside of the United States:**

Students who have completed a bachelor's degree in a nutrition related field at an international university must be accepted into Lehman and have their course evaluated by the transfer office. Students must complete a course-by-course evaluation of their foreign transcript by an approved Academy of Nutrition and Dietetics (AND) agency, [International Students](#). The DPD Director will review only transcripts evaluated by accepted Nutrition and Dietetics approved agencies. ### ***Program Retention Requirements***

A minimum cumulative GPA of 3.3 and no grade below C - in any course required for the Nutrition and Dietetics major, and successful completion of ACEDN's Core Knowledge Registered Dietitian/Nutritionist (KRDN) competency assignments in the selected courses. Individual student tracking of KRDNs is managed by the program director and DPD faculty. If a student does not meet a particular KRDN, the student is offered a chance by the DPD director or the faculty member in that course to re-do the project or an alternate assignment to meet the KRDN. Attempts are offered during the same semester of the course where the KRDN was assessed or shortly following that semester after grades have been assigned. There is no limit to the number of student attempts to meet a given KRDN. All D grades must be repeated for a better grade. If a student is consistently not doing well in their DPD courses, their advisor may start a conversation about changing their concentration to another concentration in the HPNS department, or another department. Students retain full agency to continue with the DPD program, but advisors will emphasize additional academic and career options that may suit student's interests and abilities better.

Students will be dropped from the program if their GPAs fall below the minimum. Students dropped from the program based on GPAs below the minimum requirement may reapply to the DPD when their GPA improves although readmittance into the DPD is not guaranteed. They may elect to move to Culinary Nutrition which awards a B.S. degree in Culinary and Community Nutrition but is not accredited by ACEND.

### ***Nutrition and Dietetics/DPD Curriculum***

The Didactic Program in Dietetics (DPD) curriculum meets the academic requirements to prepare students for the next steps toward a career in the field of dietetics. The Nutrition and Dietetics curriculum consists of 6 semesters, 25 courses (69 credits), including 15 courses (45 credits) for the DPD requirements. The curriculum of DPD Program is planned so that the learning is sequential, initially drawing on the liberal arts and sciences for the beginning level courses and then on foundational courses in Anatomy and Physiology (BIO181-182 or 228), Introductory Chemistry (CHE 114-115) as well as the first course in nutrition (DFN 215). The introductory nutrition course (DFN 215), Nutrition in Health Care (DFN 248) and the introduction to Food Science and Microbiology (DFN 321) serve as prerequisites for DFN courses with more advanced, professionally-oriented material. Since the science and the practice of dietetics draws upon and integrates the principles of many disciplines including

biology, chemistry, and the social sciences as well as health services and health education in addition to dietetics, foods and nutrition, these courses are part of the ACEND-accredited curriculum. Laboratory experiences are important components of the curriculum and are planned to integrate didactic instruction with hands-on activities.

After declaring Nutrition and Dietetics major and entering the Didactic Program in Dietetics (DPD), students can complete the DPD requirements within 2 years (150%) of the program length. Upon completion of the curriculum and earning a bachelor's degree in nutrition and dietetics and obtaining a Didactic Program in Dietetics (DPD) Verification Statement, students will be eligible to start an ACEND approved Dietetic Internship for which they have applied and been accepted into.

**ACEND 2022 Standards for Didactic Programs: Core Knowledge Registered Dietitian (KRDN) Competency Assessments:**

The program's curriculum must prepare students with the following core knowledge:

**Domain 1: Scientific and Evidence Base of Practice: Integration of scientific information and translation of research into practice. Knowledge Upon completion of the program, graduates are able to:**

***Distance Learning Requirements:***

The distance learning component of the DPD curriculum allows students to take greater than 50 percent of the Nutrition and Dietetics courses in Distance Learning, allowing more accessibility, timely completion of the program and increasing students' retention & graduation rates.

Through the Didactic Program in Dietetics (DPD), courses are offered in various modalities. Any of the DPD courses can be offered in Distance Learning via online synchronous, asynchronous, hybrid, blended, high Flex or face-to-face in traditional classroom settings.

### ***Distance Education Resources and Support Services for Students and Faculty:***

The library has reserve room/space for Zoom meetings in the lower level to accommodate students taking online classes. ### ***Distance Education Curriculum:***

The learning experiences in a distance learning environment are comparative to the traditional face-to-face classes. Students in distance education receive the same learning experiences, meaning, the same syllabus is used for both distance education and traditional face-to-face courses. Students in distance education have the opportunity to engage with faculty through Zoom meetings/office hours, zoom classroom meetings, and the Blackboard Collaborate live classrooms. Students in distance education participate in classroom discussion board assignments, breakout groups or chat rooms and collaborative group projects. Exams, tests, and quizzes are administered through the Blackboard. Through the DPD, faculty in each course provide ongoing assessment of core knowledge and student learning through various exams, case studies, projects, presentations, and group activities. If faculty members choose to offer an exam or quiz online, they develop the exam or quiz in the Blackboard. Learning activities are used to evaluate final student achievement of the Core Knowledge Assignments (KRDNs) administered by the faculty teaching DPD courses, with the data provided to the DPD Program Director for use in the ongoing tracking system for each DPD student. Students must earn 80% or higher on all KRDN evaluation activities and receive a “B-” or better” in all DPD Science and DPD Professional courses to complete the degree requirements and earn a Verification Statement.

## ***Policies and Procedures for Privacy and Verification of Distance Education Students:***

The City University of New York (CUNY) ensures that students enrolled in distance education are verified. All students participating in online instructions offered by any CUNY campus must log in to their sites in the Learning Management System using their CUNY credentials.

Each student is required to use their personal login information. Only students who are registered for courses have a personal login. All CUNY faculties have a personal Zoom account. Please see <https://www.cuny.edu/about/administration/offices/cis/technology-services/zoom/> Only students who are enrolled in the courses receive the Zoom link. Only students with permission are admitted to the Zoom room. Exams are timed and are given within a specified time.

## ***Assessment of prior learning and credit toward program requirements***

The college assesses prior learning in the following manner:

- **Credit by Examination:** Students who have participated in any one of the three external examination programs approved by the College such as the Advanced Placement Program (AP), the College Level Examination Program (CLEP), and the College Proficiency Examinations Program (CPEP), may receive advanced placement depending on the scores achieved and criteria set by the College. Sophomore standing will be awarded to those who have earned four full Advanced Placement course credits.
- **Credit By Departmental Examination:** All departments at Lehman College may offer credits by means of a departmental examination, provided the individual departments are convinced that the student, through previous study and/or work, is qualified to take the examination in a specific course. The department may assign either credit (representing a grade of C or better) or no credit to the examination. Students who fail this examination may not repeat it. Students requesting credit by departmental examination must pay the Qualifying Examination Fee as listed in the section on "Non-Instructional Fees" in the chapter on "Tuition and Fees" in the Lehman Bulletin, [Credit by Examination | Lehman College Catalog \(cuny.edu\)](#).

The maximum number of credits students may earn through external examinations and life-experience credit (awarded through the [Adult Degree Program](#)), exclusive of Advanced Placement examinations, is 30. (For further information, consult the Office of Academic Standards and Evaluation, please see <https://www.lehman.edu/academic-standards/index.php> and <https://www.lehman.edu/office-academic-programs/>, Shuster Hall, Room 280) and Office of the Registrar <https://www.lehman.edu/registrar/alternative-credit-options/>

Second degree students in the ACEND-approved program must take at least half of the Nutrition and Dietetics major (DPD courses) at Lehman. This is equivalent to a minimum of 31.5 credits.

The courses at Lehman that must be taken to satisfy DPD requirements are based on the decision of the DPD Director and faculty as to the knowledge still required to fulfill required DPD competencies.

Students enrolled as non-matriculated students in the DPD who already have completed a BS degree and who have taken DPD-required courses at other institutions must complete at least 12 credits at Lehman in DPD or other approved courses. The courses at Lehman that must be taken to satisfy DPD requirements are based on the decision of the DPD Director and faculty as to the knowledge still

required to fulfill required DPD competencies.

Transfer evaluation of courses taken at previous institutions is based on an assessment of the syllabi, required textbooks, activities, and assignments in order to determine that the learning objectives are consistent with program requirements. Please see Lehman's policy on Transfer credits, [Transfer Credit | Lehman College Catalog \(cuny.edu\)](#). Generally, for course recency, DPD coursework must have been completed within the past 5 years in order for the credits to be applied to the current program. The DPD director is responsible for reviewing all prior coursework and has discretion in applying credits towards DPD completion.

### ***Formal assessment of student learning and regular reports of performance and progress***

Student learning is assessed throughout the semester in each course by a variety of methods including attendance and participation in classroom activities and/or in discussion groups online, homework assignments, case studies, quizzes and examinations, oral and written reports, hands-on activities and written reports in laboratories, group projects, and research papers. Students receive informal and formal feedback and grades throughout the semester and a final grade for each course is entered on the student's transcript at the end of the semester. Students must meet the college academic requirements that are established and set forth in Degree-Works and the college policies regarding academic integrity and the ethical behavior in order to continue successfully in the DPD program. Academic Advisors and instructors provide student support. The Science Learning Center (SLC), Instructional Support Services Program (ISSP) and the Leonard Lief Library are ideal resources for support.

Students are encouraged to complete academic planning early in their college career. This would involve contact with their academic advisor and the Department of Health Promotion and Nutrition Sciences (HPNS advisor). Additionally, students have access to their academic plans on Degree Works, [DegreeWorks | Lehman College](#) and the dietetics and nutrition suggested course sequencing checklist of required courses for the major, located on the HPNS and DPD website ([Health Promotion & Nutrition Sciences | Lehman College](#)).

Degree Audit is CUNY's degree audit system that provides individualized reports to help students track their progress toward completing their degrees. The Degree Audit report, used by students and advisors, identifies both completed and outstanding requirements and provides a current list of courses that can be taken to satisfy them.

Students have access to registration, transcripts, [Office of the Registrar | Lehman College](#). Students have access to CUNY first grade reports, Blackboard (now Brightspace grade book). Students will meet with an advisor once per semester. Each DPD course listed in the handbook requires a minimum of B- and no grade less than C- in science courses. Students are alerted via email to meet with the program director or an advisor once per semester to review their progress in the major and to stay on track for graduation.

### ***DPD Completion/Graduation Requirements***

To graduate from Lehman College, a minimum of 120 earned credits is required, [Academic Standards | Lehman College Catalog \(cuny.edu\)](#). To graduate from the DPD and receive a DPD Verification Statement, a cumulative GPA of at least 3.3 and a minimum C- is required in all courses required for the major. This grade requirement applies to all of the following courses: BIO 181-182 or 228, CHE114-115, 120-121, DFN120 or 250 – 259 (Lab Special Topics I), 200, 215, 220 or 250 – 259 (Lab Special Topics II), 221, 248, 321, 340, 341, 348, 369, 430, 437, 441, 445, 448, 471.

Note: Students may graduate from Nutrition and Dietetics major without receiving a DPD Verification Statement if they don't comply with the following rules for obtaining the Verification Statement. The



college has no time frame nor age to complete the degree requirements. However, ACEND's goal is that students should complete the DPD within 2 years (150%) of the program length.

### ***Obtaining a DPD Verification Statement***

Upon successful completion of the DPD, students will obtain a DPD Verification Statement. To obtain a DPD Verification Statement a student must:

- 1) Earn the Lehman College BS degree in Nutrition and Dietetics (with Psy or Soc 166 or equivalent), Psychology, successful completion of the DPD requirements, including the required "Core Knowledge Registered Dietitian/Nutritionists (KRDN) Assessments (with a score of 80 % or better on each assignment) in the selected courses; a minimum GPA of 3.3 (with no D grades). The BS degree at Lehman requires the completion of a minimum of 120 credits including Lehman's Distribution and Core requirements, and the DFN major; or
- 2) Earn a bachelor's degree in a field other than Nutrition and Dietetics, AND complete the courses required for the DPD as well as PSY or SOC 166 (or equivalent) and earn a second bachelor's degree at Lehman with a minimum of 31.50 credits in Lehman's DPD with a minimum GPA of 3.3 (with no D grades); or
- 3) Earn a bachelor's degree in a field other than Nutrition and Dietetics, AND complete the courses required for the DPD as well as PSY or SOC 166 (or equivalent) as a non-matriculating undergraduate student with a minimum of 12 credits in Lehman's DPD with a minimum GPA of 3.3 (with no D grades); or
- 4) Earn a bachelor's degree in a field other than Nutrition and Dietetics, but complete the DPD as well as PSY or SOC 166 (or equivalent) while pursuing an MS degree in nutrition (and taking some of the DPD requirements as graduate courses) with a minimum GPA of 3.3 (with no D grades).

### **In addition to the above, the following are required:**

- 5) Complete all DPD requirements within 150% of the program time planned or program length.
- 6) Complete the "Request for DPD Verification Statement" google form. Please note that the most current forms may differ slightly and may be obtained from the DPD Director.

- 7) Submit proof of certification as a [ServSafe](#) Food Manager (a valid SERV Safe Certificate). Note SERV Safe expires within five years of the issue date.
- 8) Submit proof of completion of the Plagiarism tutorial at [Certification Tests: How to Recognize Plagiarism: Tutorial and Tests, School of Education, Indiana University Bloomington \(iu.edu\)](#)
- 9) Request official transcripts from all institutions attended to be sent to the DPD Director via email (Dr. Andrea Plunkett ([andrea.plunkett@lehman.cuny.edu](mailto:andrea.plunkett@lehman.cuny.edu))).
- 10) DPD Verification Statement will be issued (via email) within 7 – 10 business days of receiving all required documents and forms.

**Note:** The DPD Verification Statement Examination is required for students who declare the Nutrition and Dietetics major and the DPD prior to spring 2025 semester. It is strongly recommended that students request a DPD VS within one year of the DPD completion in order to ensure eligibility for a Dietetic Internship.

The DPD follows Lehman College policy for time off from the program. If a student desires to take time off from the program, the maximum time allowed is 2 semesters, after which readmit is required with the Undergraduate Admissions Office. ***Grade Appeals***

Grade Appeals are submitted to the Office of the Registrar [Academic Standards and Evaluation - Appeals FAQs - Lehman College](#) and [Undergraduate Appeals - Lehman College \(smapply.io\)](#). Students dissatisfied with a grade received in a course should first consult the instructor of the course. It is the instructor's sole judgment that determines the grade recorded in the Office of the Registrar. The instructor's first judgment is always taken. Second and later judgments resulting from personal appeals and hardship claims are never honored. Occasional errors do occur, and these are always corrected promptly when properly certified by the instructor to the Office of Academic Standards and Evaluation <https://www.lehman.edu/academic-standards/index.php> and <https://www.lehman.edu/academic-standards/appeals-faq.php>

When a student considers a grade unjust, he/she should first confer with the instructor. Students are required to initiate grade appeals before the end of the eighth week of a semester following the entry of a permanent grade. Second judgments and additional work are not permitted. If a student is not satisfied that justice has been done, he/she may appeal in writing to the department chair. If the chair is the instructor in question, the senior member of the department Personnel and Budget Committee will act for the chair.

- 1) The chair will appoint a review committee of at least two department members who, with the chair, will review the appeal. The committee will examine all materials relevant to the appeal, submitted by both the instructor and the student, and will prepare a written report of its findings, either sustaining the original grade or recommending a change.

- 2) The chair will notify the student, the instructor, and the Office of Academic Standards and Evaluation of the committee's decision. If the committee recommends a grade change, the chair will forward that recommendation with the decision.
- 3) The decision of the review committee will be binding on both parties.

### ***Academic Integrity/Disciplinary/Termination procedures***

DPD students must also comply with the Code of Ethics for the Profession as described by the Academy of Nutrition and Dietetics <https://www.eatright.org/code-of-ethics-for-rdns-and-ndtrs>. Students are also required to successfully complete an online course on plagiarism at <https://plagiarism.iu.edu/index.html>. A faculty member who suspects that a student has committed a violation of the CUNY Academic Integrity Policy shall review with the student the facts and circumstances of the suspected violation whenever feasible. Thereafter, a faculty member who concludes that there has been an incident of academic dishonesty sufficient to affect the student's final course grade shall report such incident on a Faculty Report Form in substantially the same format as the sample annexed to this Policy and shall submit the Form to the college's Academic Integrity Officer, copying his/her Department Chair. Academic sanctions may include but are not limited to the following:

- 1) a grade of F on the paper or examination; the student may be given the option of submitting a similar but additional project for grading;
- 2) a grade of F on the paper or examination, as above, but with no option to submit additional work;
- 3) a grade of F for the course.

Disciplinary procedures are governed by [Article 15 of the Board of Trustees Bylaws](#). In the event the student is found guilty of academic dishonesty by a Faculty-Student Disciplinary Committee, penalties that may be imposed include but are not limited to: 1) suspension from the College or 2) expulsion from the College. Although the Office of the Vice President for Student Affairs will be guided by the recommendation of the instructor, it reserves the right to seek disciplinary sanctions under the disciplinary procedures.

The following definitions and examples are adapted from the CUNY Policy on Academic Integrity.

Cheating is the unauthorized use or attempted use of material, information, notes, study aids, devices, or communication during an academic exercise. Examples of cheating include, but are not limited to the following:

- 1) Copying from another student during an examination or allowing another student to copy your work.
- 2) Unauthorized collaboration on a take-home assignment or examination.
- 3) Using illegal notes during a closed-book examination.
- 4) Taking an examination for another student, or asking or allowing another student to take an examination for you.
- 5) Changing a graded exam and returning it for more credit.
- 6) Submitting substantial portions of the same paper for more than one course without

informing each instructor.

- 7) Preparing answers or writing notes in a blue book (exam booklet) before an examination.
- 8) Allowing others to research and write assigned papers or do assigned projects, including the use of commercial term paper services.
- 9) Giving assistance to acts of academic misconduct or dishonesty.
- 10) Fabricating data (all or in part).
- 11) Submitting someone else's work as your own.
- 12) Unauthorized use during an examination of any electronic devices, such as cell phones, palm pilots, computers, or other technologies to send or retrieve information. Plagiarism is the act of presenting another person's ideas, research, or writings as your own.

Examples of plagiarism include, but are not limited to the following:

- a. Copying another person's actual words without the use of quotation marks and citations.
- b. Presenting another person's ideas or theories in your own words without acknowledging the source.
- c. Using information that is not common knowledge without acknowledging the source.
- d. Failing to acknowledge collaborators on assignments.
- e. Purchasing or downloading term papers online.
- f. Paraphrasing or copying information from the Internet without citing the source.
- g. Cutting and pasting" from various sources without proper attribution.

Although the DPD follows Lehman College and the City University of New York (CUNY) procedures for student complaints, the following Student Complaint Policy for the DPD has been established.

Student Complaint Policy Didactic Program in Dietetics, Lehman College:

The Didactic Program in Dietetics (DPD) follows Lehman College and the City University of New York (CUNY) procedures related to grade appeals, the Code for Academic Integrity, the Code of Students Rights and Responsibilities, FERPA Rights Disclosure, and complaint procedures.

Concerns or complaints regarding the DPD should follow the steps below:

1. Any student with a concern or complaint should feel free to contact the DPD Director by email, phone, or in person.

2. If resolution is not achieved, the student should contact the Chair of the Department of Nutrition and Food Sciences.
3. If resolution is not achieved, the student should contact the Dean of the College of Health Sciences Nursing and Social Work.
4. If resolution is not achieved, the student should contact the Lehman Provost.
5. If resolution is not achieved, the student should contact the President of Lehman College Complaint Procedure.
6. If resolution is not achieved at the University level, any student who still has an unresolved complaint related to ACEND Accreditation Standards should contact the Accreditation Council for Education of Nutrition and Dietetic (ACEND) and follow the complaint procedures outlined by the accrediting body. 7. At no time during the process of filing a complaint with the Didactic Program in Dietetics, the Department of Health Promotion and Nutrition Sciences (HPNS), Lehman College, or ACEND will there be any retaliation to the student due to the filing of such complaint. The program must maintain a record of students complains for seven years, including the resolution of complaints.

### ***Academic Standards***

A student who does not meet the required minimum semester or cumulative indices or whose cumulative grade point index at the College falls below 2.0 is automatically placed on probation. Please see [Academic Standards | Lehman College Catalog \(cuny.edu\)](#)

(Students must have the retention indices of 1.5 for the first four courses or 12 attempted credits of 1.75 for the first eight courses or 24 attempted credits, and of 2.0 for 25 or more attempted credits, and a 2.0 semester index thereafter. Total number of credits attempted include Lehman College F, FIN, J, W, WF, WN, WU, PEN, ABS, P, NC, Y, R, or their equivalents, and all transfer credits.)

During this probationary period, a student maintains his/her academic standing with the College. After one semester of probation, a student who still does not meet the minimum requirements will be dropped from the College and is required to remain out at least one semester. Students may appeal to the Committee on Admission and Standing if they have not previously done so.
