INDEPENDENT AUDITORS' REPORT

The Board of Directors
The Lehman College Student Child Care Center, Inc.:

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of The Lehman College Student Child Care Center, Inc. (the Corporation) as of and for the years ended June 30, 2025 and 2024, and the related notes to financial statements, which collectively comprise the Corporation's financial statements as listed in the table of contents.

In our opinion, the financial statements present fairly, in all material respects, the net position of The Lehman College Student Child Care Center, Inc. as of June 30, 2025 and 2024 and the changes in its net position and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Corporation and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Corporation's ability to continue as a going concern for twelve months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Corporation's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Corporation's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that management's discussion and analysis be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other

knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Management's Discussion and Analysis

June 30, 2025 and 2024

The intent of management's discussion and analysis (MD&A) is to provide readers with a comprehensive overview of The Lehman College Student Child Care Center, Inc.'s (the Corporation) financial position as of June 30, 2025 and 2024, and changes in its net position for the years then ended. Since this MD&A is designed to focus on current activities, resulting changes, and currently known facts, it should be read in conjunction with the accompanying audited financial statements and related notes.

Financial Highlights

- Total assets equaled \$1,167,867, a decrease of \$77,866 or 6% from the previous fiscal year.
- Total net position equaled \$1,160,783, a decrease of \$10,082 or 1% from the previous fiscal year.
- Operating revenue totaled \$471,240, a decrease of \$836,863 or 64% from the previous fiscal year.
- Operating expenses totaled \$516,319, a decrease of \$895,125 or 63% from the previous fiscal year.

Financial Position

The Corporation's net position, the difference between assets and liabilities, is one way to measure the Corporation's financial health. Over time, increases and decreases in the Corporation's net position is one indicator of whether its financial health is improving or declining.

Statements of Net Position

The following summarizes the Corporation's assets, liabilities and net position as of June 30, 2025 and 2024, under the accrual basis of accounting:

At June 30, 2025, the Corporation's total net position was \$1,160,783 compared to \$1,170,865 at June 30, 2024. This represents a decrease of \$10,082, or 1%, from the previous fiscal year.

At June 30, 2025, the Corporation's total liabilities decreased by \$67,784 or 91%. This is due to the Corporation being in the process of formally dissolving its 501(c)(3) status, and all vendor payments have been processed through Herbert H. Lehman College (the College).

There were no other significant or unexpected changes in the Corporation's assets and liabilities.

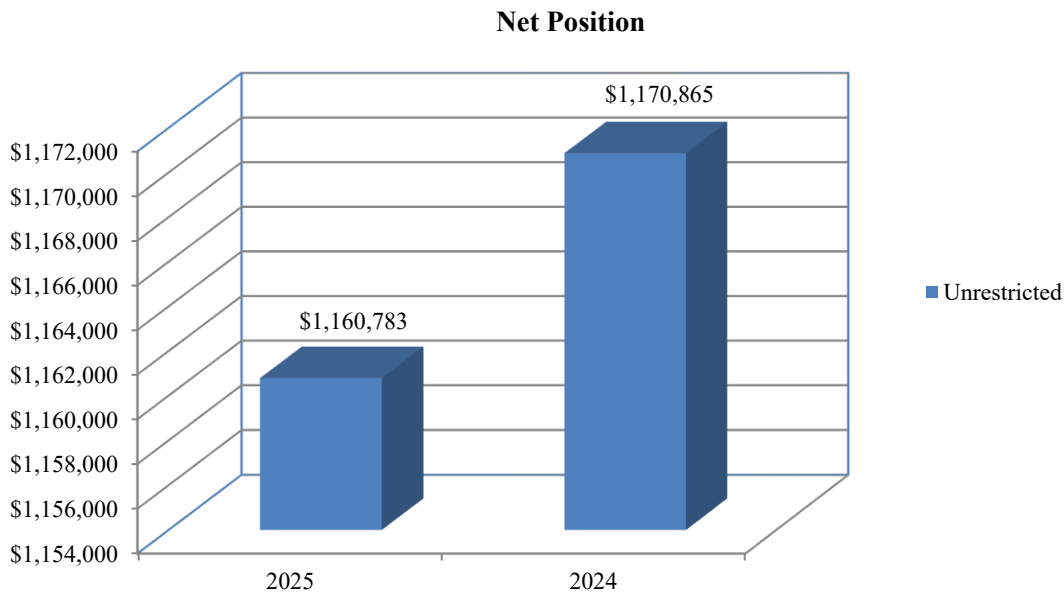

At June 30, 2024, the Corporation's total net position was \$1,170,865 compared to \$1,241,078 at June 30, 2023. This represents a decrease of \$70,213, or 6%, from the previous fiscal year.

At June 30, 2024, the Corporation's total liabilities decreased by \$243,424 or 76%. This is largely due to the timing of payments due to Imagine Early Learning Centers, LLC (Imagine) at June 30, 2024 compared to the previous fiscal year.

There were no other significant or unexpected changes in the Corporation's assets and liabilities.

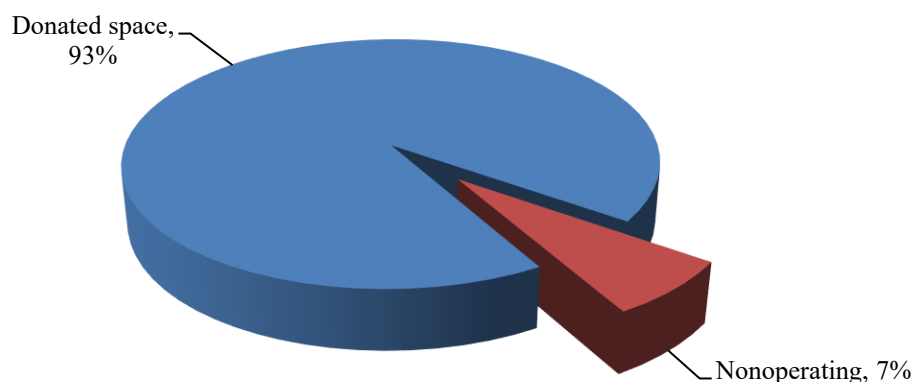
The Corporation's total revenue for the year ended June 30, 2025, was \$506,237, a decrease of \$834,994 or 62% from the previous year. This decrease was largely due to the Corporation being in the process of dissolving its 501(c)(3) status and all inflows of operating revenues including the funds from the State and Federal governments, being received directly by the College.

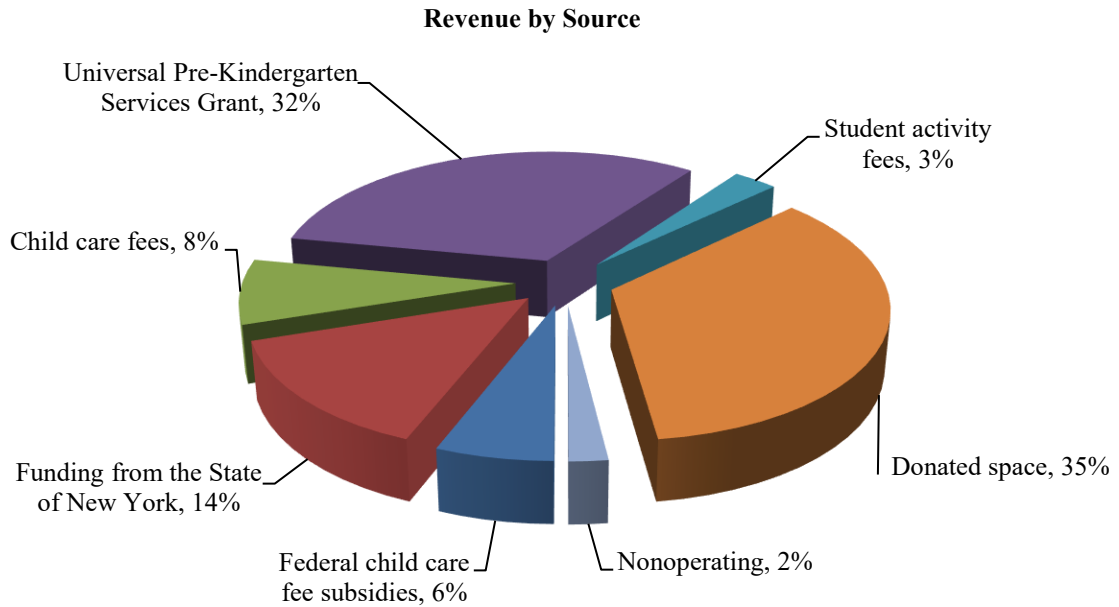

The Corporation's total revenue for the year ended June 30, 2024, was \$1,341,231, a decrease of \$106,182 or 7% from the previous year. This decrease was largely due to a reduction in Federal funding from the loss of the CCampus grant, and a decrease in NYS funding due to the reduction in Stabilization grant monies. Partially offsetting these declines were increases in other state and Federal revenue and Universal Pre-Kindergarten (UPK) due to increased enrollment.

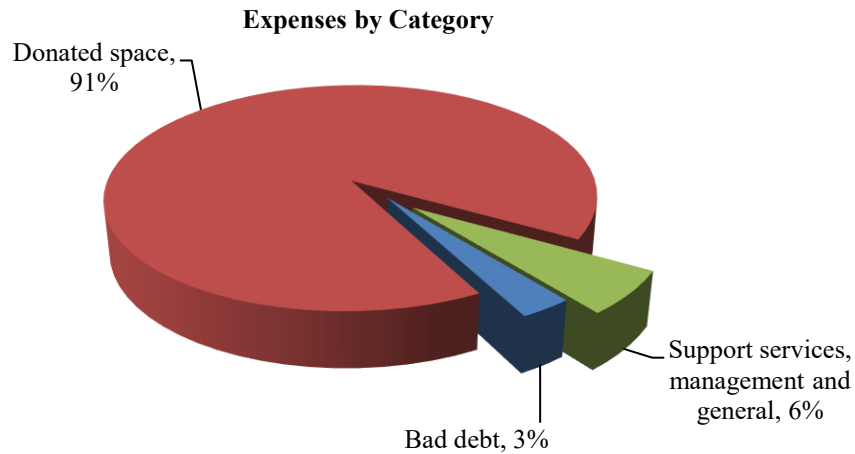

Total operating expenses for the year ended June 30, 2025, were \$516,319, a decrease of \$895,125 or 63% from the previous fiscal year. This is primarily the result of the Student Child Care Center being in the process of dissolving the 501(c)(3) status, and all vendor payments have been processed through the College.

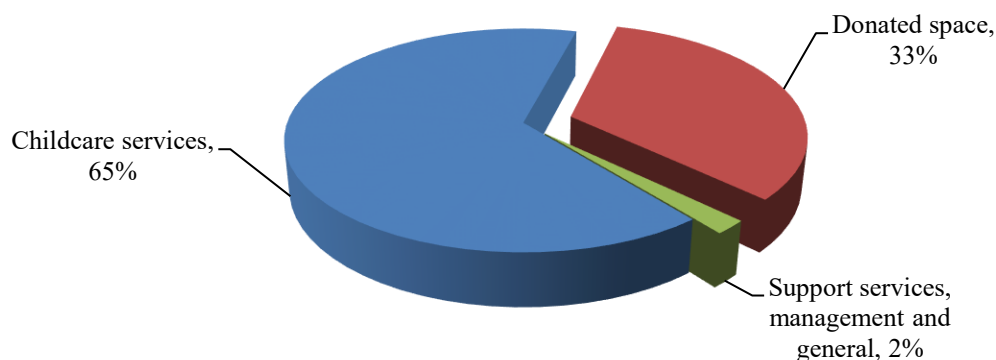
Total operating expenses for the year ended June 30, 2024, were \$1,411,444, a decrease of \$12,023 or 1% from the previous fiscal year. The major component of this was a decrease in bad debt relating to Cares Act funding through Imagine.

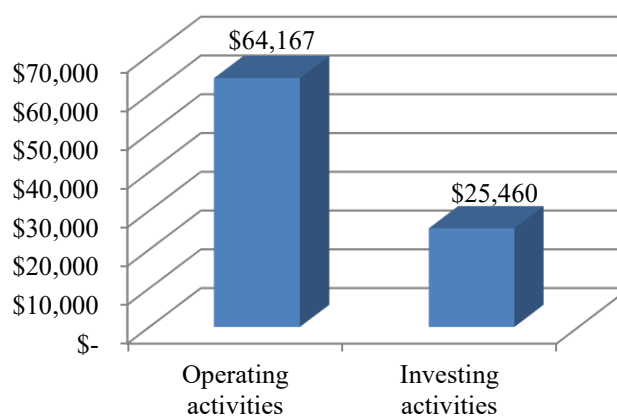
Expenses by Category

The Corporation's total cash on June 30, 2025, was \$1,037,505, an increase of \$89,627 from the previous fiscal year. This fund represents the amount that will be distributed to the College once the dissolution of the Corporation is completed.

Economic Factors That May Affect the Future

The Corporation is in the process of dissolving its 501(c)(3) status. The decision to pursue this course of action is part of a broader initiative to enhance the operational effectiveness of our childcare services and align them more closely with institutional goals.

Notes to Financial Statements

June 30, 2025 and 2024

(1) Nature of Organization

The Lehman College Student Child Care Center, Inc. (the Corporation) was organized to operate within the bylaws, policies and regulations of The City University of New York (CUNY) and the policies, regulations and orders of Herbert H. Lehman College (the College). The purpose of the Corporation is to provide an educational and development program for children of registered degree students at the College during times of regularly scheduled college classroom instruction in order that students with childcare responsibilities may pursue their educational programs at the College.

The Corporation was organized exclusively for charitable, educational and scientific purposes and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.

Although the Corporation is a separate and independent legal entity, it carries out operations which are integrally related to CUNY and, therefore, is included as a part of CUNY's financial reporting entity.

On June 30, 2024, the College elected to contract with a third party to provide childcare services on Campus. Accordingly, the College is in the process of dissolving the Child Care 501(c)(3) entity. This strategic move aims to streamline operations, enhance service delivery to students, and reduce overall costs of the College.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The Corporation's accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and applicable Governmental Accounting Standards Board (GASB) pronouncements.

For financial reporting purposes, the Corporation is considered to be a special-purpose entity engaged only in business-type activities. GASB defines business-type activities as activities financed in whole or in part by fees charged to external parties for goods or services. Accordingly, the accompanying financial statements have been prepared using the economic resources measurement focus and the accrual basis of accounting in accordance with GAAP, as prescribed by GASB. For financial reporting purposes, the Corporation is also considered to be a discretely presented component unit of the University, as defined by GASB.

(b) Net Position

The Corporation's resources are classified into the following net position categories:

Net investment in capital assets - Capital assets, net of accumulated depreciation and outstanding principal balances of debt, if any, attributable to the acquisition, construction, or improvement of those assets.

(2) Summary of Significant Accounting Policies, Continued

(b) Net Position, Continued

Restricted - non-expendable - Net position subject to externally imposed stipulations requiring the Corporation to maintain them in perpetuity.

Restricted - expendable - Net position whose use is subject to externally imposed stipulations that can be fulfilled by the actions of the Corporation or the passage of time.

Unrestricted - All other net position, including net position designated by actions, if any, of the Corporation's Board of Directors.

At June 30, 2025 and 2024, the Corporation had no restricted net position.

(c) Cash

Cash is comprised of highly liquid instruments with original maturities of 90 days or less.

(d) Accounts Receivable

Accounts receivable are charged to bad debt expense when they are determined to be uncollectible based upon a periodic review of the accounts by management. Accounting principles generally accepted in the United States of America require that the allowance method be used to recognize bad debts; however, the effect of using the direct write-off method is not materially different from the results that would have been obtained under the allowance method.

(e) Investments

The Corporation has investments held in CUNY in an investment pool which is under the control of the Committee on Fiscal Affairs of the Board of Trustees of CUNY (the Committee). Several investment advisory firms are engaged to assist the Committee in its investment pool portfolio management, which is comprised of cash and cash equivalents, corporate bonds, equities, mutual funds, U.S. agency mortgage-backed securities, U.S. government bonds and foreign bonds. Realized and unrealized gains and losses are included in the statements of revenue, expenses and changes in net position.

(f) Capital Assets

Capital assets are stated at cost at the date of acquisition or fair value at the date of contribution, if donated. In accordance with the Corporation's capital asset policy, capital assets are defined as any asset with a useful life of at least five years and a cost or value at the time of receipt of \$5,000 or more for all computer, equipment, furniture and fixtures and capital improvements. Depreciation is computed using the straight-line method over the estimated useful life of the asset and is not allocated to the functional expense categories. The estimated useful life of computer, equipment, furniture and fixtures and capital improvements is five years and ten years, respectively.

(g) Revenue Recognition

Revenues are recognized in the period earned. Included in revenues are childcare fees and appropriations and grants from the State of New York, the City of New York through CUNY which are received in connection with the Corporation's objective of providing childcare services.

(g) Revenue Recognition, Continued

A significant reduction in the level of this support, if it were to occur, could have a significant effect on the Corporation's programs and activities.

(h) Donated Space

The Corporation operates on the campus of the College and utilizes facilities provided by the College. The estimated cost savings associated with such arrangements is recorded as donated space and is recognized as revenue and expenses in the accompanying financial statements based on the fair value of such facilities (note 9).

(i) Functional Expenses

The costs of providing the various programs and other activities have been summarized on a functional basis in the statements of revenue, expenses and changes in net position. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

(j) Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and judgments that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

(k) Subsequent Events

The Corporation has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

(l) Income Taxes

The Corporation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code (the Code), therefore, no provision for income taxes is reflected in the financial statements. The Corporation has been classified as a publicly supported organization that is not a private foundation under Section 509(a) of the Code. The Corporation presently discloses or recognizes income tax positions based on management's estimate of whether it is reasonably possible or probable that a liability has been incurred for unrecognized income taxes. Management has concluded that the Corporation has taken no uncertain tax positions that require adjustment in its financial statements. U.S. Forms 990 filed by the Corporation are subject to examination by taxing authorities.

(3) Concentration of Credit Risk

Custodial credit risk of deposits is the risk that the Corporation's deposits may not be returned in the event of a bank failure. At June 30, 2025, \$808,497 of the Corporation's bank balance of \$1,058,497, was exposed to custodial credit risk. At June 30, 2024, \$697,878 of the Corporation's bank balance of \$947,878 was exposed to custodial credit risk.

(4) Investments

Custodial credit risk as it relates to investments is the risk that in the event of failure of the counterparty of a transactions, the Corporation will not be able to recover the value of its investment portfolio that is in the possession of that failed counterparty. At June 30, 2025, and 2024, the Corporation's entire investment portfolio balance of \$120,015 and \$110,478, respectively, was exposed to custodial credit risk, as it was uninsured and uncollateralized.

(5) Investments in CUNY Investment Pool and Related Investment Income

The Corporation's investments in the investment pool are comprised of assets which are pooled and invested by and under the control of the Committee. Pooled investments include equity and fixed income securities. Investments as of June 30, 2025 and 2024, are comprised of the following:

(7) Federal and State Funding

CUNY is eligible to receive a portion of Child Care Federal Funds for the purpose of increasing the availability, affordability and quality of childcare. The grant is intended to provide funding to all functions and support services that are traditionally associated with childcare programs and to facilitate the expansion of childcare to student parents. The Corporation had no allocations of grant funds for the year ended June 30, 2025. The Corporation's allocations of grant funds for the year ended June 30, 2024 amounted to \$76,513. Grant amounts represent tuition subsidies to eligible students and are reported in the statements of revenue, expenses and changes in net position.

In addition, the Corporation had no amounts allocated during the year ended June 30, 2025 from the State of New York through tax levy appropriations for the provision of childcare services at senior and community colleges. There was no state funding for the year ended June 30, 2025 and total state funding for the year ended June 30, 2024, was \$183,500.

(8) Child Care Services

The Corporation has engaged Imagine Early Learning Centers, LLC (Imagine) to provide childcare services to children of students at the College through June 30, 2024. For the year ended June 30, 2025, no childcare services were expensed and no amounts were owed to Imagine at June 30, 2025. For the year ended June 30, 2024, childcare services expenses totaled \$913,410, of which \$74,868 was payable to Imagine on June 30, 2024.

(9) Donated Space

The Corporation utilizes certain facilities provided by the College. The estimated fair value of facilities are included in the accompanying statements of revenue, expenses and changes in net position. Donated facilities for the years ended June 30, 2025 and 2024 amounted to \$471,240.

(10) Related Party Transactions

At June 30, 2025, the Corporation was not owed any amount from other College entities. At June 30, 2024, the Corporation was owed \$33,885 from other College entities.

(11) Accounting Standards Issued But Not Yet Implemented
